The HHL Scholarship for Woman in Business is especially for female applicants from all countries for HHL's part-time M.Sc. Finance Program.

With its **Scholarship for Women in Business**, HHL would like to support excellent female candidates of all national backgrounds who present strong motivation and outstanding professional and academic credentials and who are willing to become active members of the HHL community. The scholarships will support HHL's goal of achieving a truly heterogeneous part-time M.Sc. Finance class. Successful candidates will receive a tuition reduction of **up to EUR 5,000** for the part-time M.Sc. Finance Program.

Scholarship Selection Process

Please submit the scholarship application via email to <u>d.ruske@hhl.de</u>, parallel to your program application. The selection committee evaluates the application and in case of a successful admission to the part-time M.Sc. Finance program, you will be informed about the scholarship decision immediately.

Selection Criteria

Applicants must hold an undergraduate degree in any field (at least 180 ECTS credits), as well as a minimum of three years of work experience. Furthermore, an above average HHL Entry Test or GMAT score is required.

Only applicants who apply for HHL's part-time M.Sc. Finance Program are eligible to apply for this scholarship.

Submitting Your Application & Deadline

Your scholarship application must be submitted together with the program application by uploading it on the <u>online application portal</u> under the section *Documents to Upload*. Please bear in mind that your chances to receive financial support increases the earlier you apply.

Application Documents

For your complete application, the following documents are compulsory:

- ✓ A completed part-time M.Sc. Finance application (online at http://study.hhl.de)
- ✓ HHL Entry Test report / GMAT score report
- ✓ Woman in Business Scholarship questionnaire (next page)
